Re: Notice of Liability

Dear Rev. MacDougall,

It's been 10 days since I and Dr Laura Braden, an expert in Microbiology and Immunology, met with you and the Chancellor of the Diocese of Charlottetown, Rev. Chris Sherren. At that meeting, we alerted you to the fact that the approval of the so-called gene-based COVID-19 vaccines was premature and reckless, and that their continued administration to Islanders, especially to the recently-added 5-11 year age group who, **for reasons having to do with the absence of receptors in their respiratory system allowing the virus to bind**, are at zero risk from the virus, which the actual data from the past two years in Canada proves. The mRNA injections do, however, pose a certain risk of harm, now that it is understood how they work photogenically within the body, causing multiple diseases. As a result, the injection campaign in PEI needs to be immediately halted.

I indicated in the course of our meeting that I would be sending you an official "notice of liability". This letter is that Notice of Liability, is being SERVED to you personally.

You were informed that these injections are not approved, that targeted groups such as children and pregnant women were EXCLUDED from the few trials undertaken on a small, short-term basis for the Interim Authorization, which is unconscionable and against every medical review and approval process established, but are unethically not being followed. These injections have not undergone the safety trials required for approval, but since granted only an "Interim (i.e., emergency) Use Authorization," and the injections therefore constitute human experimentation in violation of the Nuremberg Code. Any attempt to coerce someone to receive these injections – which is happening with people in countless families (Catholic families) losing their gainful income for not agreeing to participate in this global experiment maiming and killing so many already, with a promise that number will rise exponentially very soon.

Our concerns expressed to you and Rev. Sherren regarding the potential dangers of these experimental gene-editing agents being injected into children are founded on common textbook knowledge of immunology and medicine, and the mechanisms at play with this type of biological and biochemical interaction at the genetic and molecular level within the body.

The dire predictions, and now hard statistical data and evidence, (evidence from autopsies and medical investigations into how these injections impact people negatively and cause disease, disability and death) confirm with no doubt that **the administration of the agents invariably leads to pathological events causing, among others, life-threatening thrombotic events.**

You were called upon by me to correct the disinformation that the Catholic Church is currently disseminating to parishioners at our meeting; asked to stop encouraging them to receive the injections **as an act of charity and concern for the safety and well-being of others**, when the truth is that the injections do not prevent either contracting or spreading the virus, nor have the companies selling these technologies ever made that claim, but are now proven to cause untold damage within the body, in various ways in different stages with different people, as a result of their pathogenic qualities.

You were also asked to speak publicly to call upon the government to halt this dangerous program immediately, until such time as the claims that are being made can be addressed and answered, which the government currently refuses to do. You were also informed of the extreme censorship with the media, social platforms and government and health officials, and the urgent need for the church to be a vehicle disseminating correct information that will begin to undo the great deception.

Despite the extreme urgency of the matter, given that the vaccination program for 5-11 year old children was

being rolled out at the time we met, you have remained silent. Thousands of children have now been poisoned, damaged for life, and we will begin to see catastrophic consequences that we hope you have taken the time to learn about from leading (but censored) world experts.

Original fears about these injections have been confirmed and further pathways leading to injury and death by the experimental agents have been uncovered through new scientific discoveries in 2021. The rush to vaccinate first and research later has resulting in policy being divorced from the relevant evidence.

You are hereby placed on notice that you stand to be held personally and individually responsible for causing foreseeable and preventable harm and death to Island Catholics from COVID-19 vaccines, and for supporting crimes against humanity, defined as acts that are purposely committed as part of a widespread or systematic policy, directed against civilians, committed in furtherance of state policy. The gravity of your deeds is now laid out before the world. For the sake of what is good and true, rise up now against this evil scourge, or down in history books in indelible shame and disgrace.
